Dear Trustee Mauldin:

The University of Alabama ("University") has received competitive bids for Construction Package $B-3^{rd}$ Floor, of the H.M. Comer Hall Interior Renovations project ("Project"). The Project consists of the renovation of select areas of the 3^{rd} Floor of H.M. Comer Hall which will be vacated following the completion of the 2^{nd} floor renovation and will provide more usable space and increase operational efficiencies and effectiveness for the future occupants including the College of Engineering's Financial Services, External Affairs, and Dean's Office Administrators.

The Project was advertised in the following paper of general circulation per Title 39, Public Works provisions of the Code of Alabama requirements: *The Tuscaloosa News*. The advertisement described the scope of work for the Project and requested interested firms to submit their qualifications. After reviewing pre-qualification statements, the University determined that the following general contractors met the requirements:

- UA Master List for General Contractors
- N.C. Morgan Construction
- Rogers Building Company, LLC
- Trawick Contractors, Inc

On October 1, 2024, at 1:00 p.m., a public bid opening was held, and three pre-qualified general contractors submitted bids. The Designer of Record, KPS Group Inc., of Birmingham, Alabama, certified Snow-Blakeney Construction, Inc., of Tuscaloosa, Alabama, as the lowest responsive and responsible bidder from the UA Master List for General Contractors. Their adjusted base bid in the amount of \$696,171, which is under the amount budgeted for the work. I have attached the Certified Bid Tabulation for your review.

In addition to the above bid, in accordance with Title 39, Public Works provisions of the Code of Alabama, informal proposals were solicited from multiple contractors for early demolition of the space to help maintain the Project schedule requested, and A to Z Environmental, of Tuscaloosa, Alabama, submitted the lowest proposal with a price of

\$91,200, which is reflected within Construction Package $B-3^{rd}$ Floor below, for a total Construction Package $B-3^{rd}$ Floor cost of \$787,371. The final total project budget is:
